Require a term of up to 7 years. <i>Description of product, including key attributes</i> This is a secured variable rate car loan. The key attributes are: • loan amounts from \$10,000 • loan terms of up to 7 years • variable interest rate • repayment frequency can be weekly/fortnightly/monthly • the ability to make additional repayments • a redraw facility • acceptable security for the loan must be provided and includes brand new - registrable electric, full hybrid or plug-in hybrid cars (demonstrator vehicles eligible) • monthly fee • application fee • other fees and charges may apply.
