Target Market	<i>Description of target market</i> Members aged 18+, seeking to buy or refinance a brand new, demonstrator or up to 5 years old car/boat/caravan/motorcycle/jetski, want the flexibility to make extra repayments. Need the certainty of a fixed interest rate with fixed repayments and require a term of up to 7 years. <i>Description of product, including key attributes</i> This is a secured fixed rate car loan. The key attributes are: • loan amounts from \$10,000 • loan terms of up to 7 years • fixed interest rate • repayment frequency can be weekly/fortnightly/monthly • the ability to make additional repayments • a redraw facility • acceptable security for the loan must be provided and includes brand new or used up to 5 years old - registrable cars (demonstrator vehicles eligible), motorbikes, caravans, boats and jetskis • monthly fee • application fee • early repayment fee if repaid before end of term other fees and charges may apply. Refer to the current fees and charges schedule

- A material change to the product or the terms and conditions of the product occurs which would cause the TMD to no longer be appropriate;
- Material changes to fees or rates of interest
- 20% or more of loans are paid out early
