- A material change to the product or the terms and conditions of the product occurs which would cause the TMD to no longer be appropriate;
- · Material changes to fees or rates of interest
- 20% or more owe >95% of the limit for a prolonged period of 12 months
- 5% or more overdrafts aren't secured with mortgage
